How to trace a tombstone

- 1. Find the surname
- 2. If the letter \mathcal{N} is shown, the grave is in the cemetery on the opposite side of the road (opened 1902)
- 3. For all others the number denotes where you will find the grave (refer to the plans)
- 4. The letter denotes the monumental inscription see ABCD sections (churchyard)
- 5. WM = War Memorial
- 6. $X = no \ longer \ legible$

BASSINGHAM CHURCH - INTERIOR

- I.1 This window is dedicated to the Glory of God and In loving memory of Herbert BAGULEY who died 17 November 1947. Lucy BAGULEY who died 30 May 1946 and Dorothy Mary HALES, youngest daughter of the above who died 29 September 1945.
- **I.2** Sacred to the memory of Jane the beloved and lamented wife of the Rev D S WAYLAND who died 22 Dec 1843 [?1848] aged 57.
- **I.3** Within this chancel rests in sure and certain hope of a glorious resurrection. All that was mortal of Ellen Joyce WAYLAND, eldest surviving daughter of Rev D S WAYLAND and Jane his wife. She died 30 March 1852 age 36 [?30]
- I.4 In memory of Poole SAVAGE, Gentleman who after having the space of 35 years fulfilled the duties of a confidential situation in the city of Lincoln with exemplary faithfulness and decided piety, his unostentatious benevolence and uniform consistency of conduct, departed this life 28 August 1828. In humble yet firm hope of a happy eternity, through the alone merits of an ever blessed redeemer. *aetat* 50
- **I.5** Sir William THOROLD Knt & Bart & Lady Anne THOROLD his wife gave by deed dated 21 September 1670 the sum of 40 shillings yearly forever to be distributed to eight of the poor people of this parish on St Thomas' day be the Minister Churchwarden and Overseer of the Poor or any three of them so that the Minister be one. To be paid out of the Close commonly called Tuft Hill.
- **I.6** John LAMBE of this town by his last will 1670 gave £12 the interest of which was to be paid by the rector and overseers to the poor at Christmas and Easter by equal portions.
- I.7 John GARNETT of this town by his last will 1672 likewise gave £12 the interest of which was to be paid by the rector or overseers to the poor at Christmas and Easter by equal portions.
- **I.8** Sir Christopher NEVIL Knt 1692 gave to the parish £30 the interest of which was to be paid by the rector and overseer to the poor at Christmas and Easter by equal portions. The money was laid out in the purchase of Harrisons Moor north of the Fen Lane.
- **I.9** Robert JESSOP left to the poor of this parish by will dated 4 January 1714 a rent charge of ten shillings a year for ever. To be paid on St Thomas' Day out of a close known by the name of the Four Acres which lies south of Linga Lane.
- **I.10** Poole SAVAGE, Gentleman, late of Lincoln, by his last will dated 31 July 1823 gave £200, the interest of which was to be distributed every Christmas by the minister and churchwardens amongst the poor of the parish of Bassingham whom they should think fit objects of Charity.

The following were recorded in 1833 and published in 'Monson's Church Notes', LRS vol.31. All on flat stones in the Ghancel:

She died on Sunday Feb. 13, 1825, aged 77 years. The ornament of a meek and quiet spirit is in the sight of God of great price.






